








## OPERATIONAL CONTEXT

 Kenya hosts over 804,594 refugees and asylum seekers of which more than 289,861 live in Kakuma Refugee Camp and Kalobeyei Refugee Settlement in Turkana County.

 77% of individuals in the refugee camps targeted by DCA are women and children.

 Financial exclusion has decreased by 1.7 percentage points from 11.6 percent in 2021 to 9.9 percent in 2024 mainly on account of an increase in informal utilization of financial services driven by upsurge in technology and digitization of service provision.

 Turkana and West Pokot Counties have some of Kenya's lowest Human Development Indexes of 0,37 and 0,45 against the national average of 0,59.

 Severe floods experienced in the country in April 2024, subdued business sentiment following the mid-2024 youth-led protests, and reduced public spending amid ongoing fiscal consolidation efforts are weighing on headline growth and the overall macroeconomic performance for Kenya in 2024

## WHAT WE DO

At individual level, **DCA provides life-saving humanitarian response and protection for refugees and vulnerable local communities** in crises, empowering young men and women by supporting them with education, life skills, entrepreneurship/ employability training, technical knowledge, rights awareness, entrepreneurship skills, inputs and linkages to markets, value chains and financial services to enhance their self-reliance and resilience and talent building so they can become resourceful, dignified, and proactive agents of change.

**In pursuit of the SAVE goal**, the Country Program (CP) made significant progress in helping vulnerable communities recover from drought in Turkana County and flooding in Nairobi and Nakuru counties. The success was driven by a timely and effective emergency response, where Multi-purpose Cash Transfers (MPCT) was deployed through an elaborate targeting process that ensured community participation and ownership. The interventions followed best practices, using the minimum expenditure basket to determine MPCT amounts and monthly cycles. To promote sustainability, support was also provided to Survivor and Community Led Response (SCLR) groups, enabling long-term community-led interventions in line with the humanitarian-development double nexus.

**Under the BUILD goal**, household incomes increased through improved access to quality inputs and training in agronomic and livestock practices. Climate-smart technologies boosted resilience, sustaining production under conservation agriculture and agroecology.

**The FIGHT goal** advanced land tenure security for smallholder farmers through democratized land rights and resource management. The Kenyan judiciary's adoption of the Alternative Justice System (AJS) ensured faster, more effective dispute resolution.

## WHERE WE WORK

**Country Office (Nairobi):** Organisational capacity building support to partners; Monitoring, Evaluation, Accountability and Learning; programme strategy & business development; operational support. Also serves project and partners in new geographic areas: **Kilifi, Nairobi Metropolitan** (Nairobi, Kajiado, Kiambu, Muranga & Machakos).

**Kakuma and Lodwar Office** serves the greater **Turkana** County and host/resident communities. DCA and partners work on livelihoods and resilience, financial inclusion, youth empowerment and conflict mitigation, with a strong focus on women and youth as well as enhancing the humanitarian development-peace nexus. DCA and partners work on livelihoods and resilience, financial inclusion and youth empowerment and entrepreneurship.

**Nakuru Office** serves the **Nyandarua, West Pokot, Elgeyo Marakwet, Nakuru, Baringo and Nandi Counties**. The office also serves other partner implemented projects in, **Kisumu, Siaya and Homabay Counties**. DCA and partners work in these counties focusing on agricultural production, value chain & market development, access to financing for smallholder farmers, green growth, job creation for youth and natural resource management.

## HOW WE WORK

**Livelihoods for Resilience and Self-reliance:** We promote climate-resilient agriculture, value chain development, financial inclusion, cash-based programming, non-agricultural production, business and market growth, fisheries, livestock health, and water management.

**Private Sector Engagement:** We foster strategic partnerships with private sector actors to enhance youth employment, green growth, and value chain development.

**Youth Empowerment and Gender:** Our work focuses on entrepreneurship, skills development, inclusion, and gender justice. We collaborate with national faith actors and women-led organizations advocating for women's rights and social justice.

**Peace Building & Conflict Resolution:** We facilitate peace initiatives between refugees and host communities, as well as across borders in Uganda, South Sudan, and Ethiopia.

**Local Leadership & Localization:** We strengthen civil society and grassroots organizations that support vulnerable communities, refugees, women, and youth, addressing root causes of vulnerability such as land rights and gender/climate injustice.

**Disasters & Emergency Response:** DCA provides emergency funding for multipurpose cash assistance (MPCA) and group cash, utilizing the Survivor & Community-Led Response (SCLR) approach in disaster-affected areas.

## INNOVATION

We aim at mainstreaming innovation into everything we do through researching and testing innovative sustainable solutions. Among these are:

**The DCA Youth Enterprise Fund (YEF)** – a revolving credit facility aiming to finance youth entrepreneurs to grow and expand their enterprises;

**Climate smart technologies** – cone gardens, multi-storey gardens and shade net houses, all designed to produce more crops with less water and taking up less space;

**Novel foods & Insect Farming (Spirulina, BSF, crickets & mealworm)** – an innovative solution to secure higher nutritional diet with less impact on the climate;

**Digital Learning and Accountability** – digitalization of entrepreneurship and business training for refugee youth;

**Use of the Listen Learn Act (LLA)** tool which, through digital data collection and feedback meetings with affected populations, helps us to better capture perceptions and feedback and systematically consider it in our activities.
